The Melrose Park Commission has established the following rates & policies for the 2019 season.

The Park Commission and the current Manager, Mass. Golf Management LLC, completed and are working on the following projects during fiscal year 2018:

- Grinded out and repaved Tower Parking Lot
- Replaced Fire Protection System at Fuel Station
- Feasibility Study for improvements to the Clubhouse
- Continued work with Solitude Lake Management to help maintain healthy ponds for irrigation
- Exhaust Fan installed and lighting improved in Clubhouse basement
- Extending irrigation on 6th green to 7th tee, and plant grass
- Adding stairs to the 7th and 18th tee walkups
- Replacing pump house with variable speed drive and pump
- Installing 2nd Beaver Deceiver on 4th fairway

PRIVILEGES AND RESTRICTIONS

1. **An individual applying for a resident membership** will be required to provide proof of residence in the City of Melrose to Mass. Golf Management and /or the City prior to receiving his or her membership card. Members may be required to scan their membership card at time of check in.
2. **Membership fees** cover greens fees only; cart fees are not included.
3. **Weekday only memberships** are valid Monday thru Friday. They are not valid on holidays or during times blocked out for tournaments.
4. **Junior weekday only memberships** are valid Monday thru Friday, 10:00 AM – 3:00 PM. Junior members may reserve starting times 24 hours in advance of play. Junior Memberships are not valid on holidays or during times blocked out for tournaments. Parents/guardians are required to check course availability prior to dropping off junior members.
5. **Full memberships** are valid Monday thru Sunday and holidays. They are not valid during times blocked out for tournaments.
6. **Family memberships** are open to two family members, living in the same household, who are age 19 or older.
7. **Starting times** are recommended, especially for weekend play. With the exception of junior members, members are permitted to reserve starting times up to six days in advance. On weekends, preference will be given to foursomes playing 18 holes. All members must check-in with the Pro Shop prior to their round(s).
8. **Alcohol:** Alcoholic beverages are only permitted in designated areas of the clubhouse and patio. Alcoholic beverages are not permitted on the golf course or in the parking lot. Violation may lead to revocation of membership and/or expulsion from the course.
9. **Golf carts** are not allowed on public roads or in parking lots with the exception of the following crossing areas: Clubhouse to the 1st tee, 5th green to the 6th tee, and 17th green to the 18th tee.
10. **The Park Commission reserves the right to suspend or terminate the membership of any individual who violates these privileges and restrictions as well as any other policy.**

To renew your membership for the 2019 season, including junior memberships, please return the enclosed application and payment **by Friday, April 12, 2019**. Late applications will be handled on a first come first served basis up to 300 members.
